Reservations and Payment: QTS Tours & Travel, Inc. requires a **minimum deposit of \$250.00 per person** at the time of booking if cabin assignment is requested. If QTS Tours & Travel, Inc. contracts separate air seats, an additional **\$100.00 deposit per person** will be required for airline reservations.

Cancellation and Refunds: All cancellations must be in writing. Cancellation penalties will apply to all stateroom guests and shall be assessed in the event of either partial or full stateroom cancellations, as follows:

Travel Documents: All U.S. citizens must carry a valid passport. Passports should be valid for a minimum of six months beyond estimated return date. In some countries, visas are not required for U.S. citizens. If you are not a U.S. citizen, please contact QTS Tours & Travel, Inc. to determine your visa requirement status. QTS Tours & Travel, Inc. is not responsible for issuing/handling individual visas or passports.

Cruise Documents and Tickets: Final cruise documents will be issued either 1) in-person during an orientation meeting, or 2) by mail (provided we have received full payment) approximately three weeks prior to departure.

Baggage: Each passenger is allowed two checked bags and one carry-on. This is subject to change, according to TSA and cruise carrier requirements.

Air Transportation: Unless otherwise stated, all air Travel, Inc. will be economy class. Fares are based upon levels in effect at the time of printing, and fares and flight schedules are subject to change without notice. **Airfare to/from departure airport, if any, is not included in cruise price.**

Hotels: If needed, accommodations are based on double occupancy in First Class hotels with private facilities. A limited number of single rooms are available at a higher room rate and should be requested at the time of booking.
