## GENERAL INFORMATION AND CONDITIONS

**Tour Cost:** All quoted prices are based upon currency exchange rates at the time of printing and are subject to change at any time. Should the minimum number of 40 tour members not be reached, the right is reserved to increase the tour cost accordingly.

**Reservations and Payment:** QTS Tours and Travel requires a **deposit of \$400.00** per person at the time of booking. This pays for hotel deposit. Final payment is due 70 days prior to departure.

**Cancellation and Refunds:** Please make all cancellations in writing. The following per person cancellation charges will apply in addition to any charges assessed by our suppliers. If cancelled 90 days or more prior to departure, a \$100 administrative fee will be charged. If cancelled 89 to 65 days prior to departure, a \$300.00 penalty will be charged. If cancelled 64 to 31 days prior to departure, 30% of total price will be charged. If cancelled 30 days prior or no shows are charged 100 percent of the tour price. In addition no refunds will be given for forfeited excursions, transfers, accommodations, or air tickets (issued 35 days prior to departure, 100% of air fare is non-refundable).

**Travel Documents:** A valid passport is required of all U.S. citizens. Passports should be valid 6 months after estimated return date. Visas are not required in some countries. If you are not a U.S. citizen, please call QTS Tours and Travel to determine your visa requirement status. QTS Tours and Travel is not responsible for individual visas or passports.

**Tour Documents and Tickets:** Final tour documents are personally handed during orientation or mailed, provided we have received full payment, within 3 weeks of departure.

**Baggage:** Each passenger is allowed one checked bag and one carry-on.

**Air Transportation:** **Air tickets are not included.** If requested, Air travel will be in economy class. Fares are based upon levels in effect at the time of printing and fares and flight schedules are subject to change without notice.

**Hotels:** Accommodations are based on double occupancy in First Class hotels with private facilities. A limited number of single rooms are available at a higher room rate and should be requested at the time of booking. In some hotels, single rooms are smaller than twin rooms and not always up to the same standards. The single room supplement pays for privacy, not better accommodations.

This includes but is not limited to, improper documentations, acts of God or government failure, strikes, neglect or default of any person or company providing services for this tour. Airline, ship line and railroad tickets issued shall constitute the sole contract between these companies and the passenger.
